

PRIVACY DISCLOSURE - COOKIES

This disclosure concerns Cookies, i.e. - as described below - refers to data that the instrument you are using to browse on this website exchanges as a result of browsing. With regard to your personal data other than Cookies, please refer to the specific disclosure relating to the data that may be required - and that you will want to confer - in the various sections of the website.

1. What are Cookies?

Cookies are small text files that the websites visited by the user send and store on the device used by the user to access the Internet (computer, smartphone or tablet), to be then sent back to the same websites on subsequent visits.

Cookies, usually present in users' browsers in very large numbers and often with long temporal persistence, allow collecting information on the user's browsing on the website. They are used, for example, to perform computer authentication, for monitoring sessions and storing information concerning the activities of users accessing a website. They can also contain a unique identification code that allows keeping track of the user's navigation within the website for statistical or advertising purposes.

Some operations could not be performed without the use of cookies, which in some cases are therefore technically necessary for the operation of the website.

During browsing on a website, users can also receive on their device cookies sent from websites (or web servers) other than the one being visited (third-party cookies) through elements on the website visited (such as images, maps, sounds, links to web pages of other domains on different servers, etc.).

Some cookies are stored permanently on the user's device and have a pre-established duration (persistent cookies), while others are automatically deleted when the browser is closed (session cookies).

According to current legislation, the use of cookies does not always require the express and prior consent of the user. In particular, technical cookies do not require such consent, i.e. cookies that are indispensable for the operation of the website or necessary to perform activities requested by the user.

Among technical cookies that do not require consent for their use, the Authority for the protection of personal data (ref. Prov. Jan. <u>Identification of simplified procedures for information and acquisition</u> of consent for the use of cookies – 8 May 2014) also includes:

- analytics cookies, used directly by the site manager to collect information, in aggregate form, on the number of users and how they visit the site in order to elaborate general statistics on the the service and use thereof;
- browsing or session cookies, which guarantee normal browsing and use of the website (allowing, for example, to make a purchase or for authentication to access restricted areas);
- functionality cookies, which allow users to browse as a function of a series of selected criteria (such as language, products selected for purchase) in order to improve the service rendered to the same.

For profiling cookies - i.e., those aimed at creating profiles relating to the user and used to send advertising messages in line with the preferences expressed by the same in the context of browsing the net - the prior consent of the user is required.

2. What types of cookies do we use on this website?

This website does not use profiling cookies and does not use third-party cookies.

Specifically, this website uses:

- Technical cookies strictly necessary for the operation of the website or to allow the user better use of the contents and services (session and functionality cookies).
- Analytics cookies, which allow collecting aggregate and anonymous data related to the use of the website (ex. number of visitors, pages visited, time spent on the website, etc.). With these cookies, no information is collected about the user's identity or any personal data.

Google Analytics Cookies

In particular, this website uses Google Analytics cookies, a web analytics service provided by Google Inc. (Google). These cookies allow the operation of Google Analytics and are used by Ninz S.p.A. in order to analyze the activities that occur on the website and collect anonymous statistical data about the number of visitors, the criteria of exploration, the pages visited, the average time spent, etc. These data are collected by Ninz S.p.A. in order to evaluate the actual usefulness of the information offered on the website and to improve the usability of the contents. Google uses the data collected for the purpose of tracing and examining the use of this website, compiling reports and possibly providing Ninz S.p.A. with other Google services relating to activities of the website.

In order to collect this data in a completely anonymous manner, the anonymous IP address is activated on this site, which causes the user's IP address to be truncated, thus guaranteeing the anonymity of the data collected.

If users prefer browsing not to be traced and wish to prevent the use of personal data by Google Analytics, they can deactivate Google Analytics (Opt-out) by downloading and installing <u>additional</u> <u>component for the browser</u> in use (compatible with Chrome, Firefox, Internet Explorer 8 and higher, Safari and Opera).

3. Managing preferences on cookies

When accessing any page of this website, a banner is shown that contains the brief disclosure and a link to this page. Continuing browsing (i.e. clicking on OK to close the banner or even just scrolling the page, accessing another area of the website or clicking any element of the page), the user gives consent to the use of cookies on this website. Consent to the use of cookies is recorded with a technical cookie (indicated in the table), which also allows not repeating the brief disclosure on subsequent visits of the user.

The collection of data through cookies, therefore, takes place on the basis of the consent of the party concerned (website visitor).

The provision of data is however optional; however, the full right remains for the website visitor for the possibility to:

- oppose tracking and use of personal data by Google Analytics (as described above)
- oppose recording of cookies on personal hard disk (configuring the browser to disable cookies).

Through the browser preferences, it is also possible to delete the cookies installed in the past, including the technical cookie in which the consent to the installation of cookies by this website was saved.

However, it is noted that, in the event that all or some of the cookies are disabled, it is possible that the website or some of its functions may not available or may not work properly and the user may be forced to change or manually enter some information or preferences every time the site is visited.

The data collected using cookies will not be disclosed or communicated to third parties. They may be transferred by Google outside the European Union, particularly to the United States of America. The transfer is authorized on the basis of specific decisions of the European Union and the Guarantor for the protection of personal data, in particular the decision of adequacy of the EU Commission 1250/2016 (Privacy Shield), for which no further consent is required, and Google shall guarantee its adherence to Privacy Shield.



4. Data controller

We wish to remind you that the GDPR grants you the exercise of the following rights of:

- a) access to personal data (you will therefore be entitled to have free information about the personal data held by the Controller and related processing, and to obtain a copy in an accessible format);
- b) rectification of data (following your request, we will ensure the correction or integration of your data - non-expression of evaluation elements - incorrect or imprecise, even if they have become such as not updated);
- c) withdrawal of consent (if processing is by means of consent expressed by you, you can revoke consent at any time, without prejudice to the lawfulness of processing provided before revocation)
- d) deletion of data (right to be forgotten) (for example, data are no longer necessary for the purposes for which they were collected or processed, have been unlawfully processed, must be deleted to fulfil a legal obligation; you have revoked and there is no other legal basis for processing, you oppose to processing);
